IFB# 2024-02 – SUNSET CHANNEL IMPROVEMENTS

ADDENDUM #1

This Addendum consists of two (2) pages. The information contained in this addendum shall be incorporated into the project bid and contract documents the same as if originally contained therein.

Bidders shall acknowledge receipt of this addendum in *Article 3 of the Bid Form* in the space provided. Failure to acknowledge this addendum by any prospective bidder will render the bid non-responsive.

1. QUESTIONS RECEIVED FROM PROSPECTIVE BIDDERS

- Q1: Keyed note 3 on plan sheets 17, 18, 19 and 21 calls out for a 48" Trash Rack on a 36" Manhole opening on a 72" Diameter Manhole. Can you provide a drawing that details how the manhole will be configured?
- A1: These manholes will include a standard flat top. Instead of a standard ring & cover, the contractor will install the TrashRax RS-48 (or approved equal) over the 36" opening per manufacturer's specifications.
- Q2: Is there a designated staging area for the project?
- A2: The contractor may use SSCAFCA-owned property immediately north of the intersection of Tulip Rd. & Sunset Rd. as a staging area.
- Q3: What pipe materials are acceptable for use on this project?
- A3: SSCAFCA will allow the use of galvanized steel pipe, HDPE pipe, or reinforced concrete pipe with a Manning's Roughness Coefficient of 0.013 (or less) and compliant with the provided APWA specifications.

- Q4: Is there a designated Borrow area for the project?
- A4: The contractor may excavate the required material from a SSCAFCA property located at the Northwest corner of Unser Blvd. and Westside Blvd.
- Q5: Will the existing exposed utilities be relocated prior to construction?
- A5: SSCAFCA has been in communication with utility companies with the goal of having the utilities moved prior to construction. The exact timing of utility relocation is currently unknown, however, SSCAFCA plans on starting construction in mid- to late-April.
